G. Naloxone Rescue Kits for Law Enforcement - Holly Taft & Officer Dustin Krueger
Hollie Taft provided a statistical introduction Rescue Kits. We want the quickest access to the
medication. 58 over doses in 1 year in 2016 were Narcan was used in 11 cases to save lives.
Seeking to provide Naloxone and training and its use for law enforcement. The MOU is under
legal review and policies and procedures have been a reviewed and approved by the committee.
The program could offer 1 year supply during which time a grant will be to sought to continue
the service.

H. Tri-City Care Bill for Sonja Berget - Renita Howling Wolf.

Presented a request for her mom and sister. Asking for assistance to pay for half of the bill in the amount of \$24,895.14. May qualify for Medicaid.

Motion: Councilman Fred Fox moved to execute an executive order for the balance after Medicaid for \$13,000. Councilwoman Monica Mayer seconded the motion. Vote: 3-0-0. Motion carried.

Discussion: Medicaid goes back three months leaving about two months to be paid for the extended care for about \$13,000. Al Nygard will process the Executive Order. I have another family member needs a medical referral from 2015 and another family member that has a life threatening issue 2016 and never notified until three weeks ago. Councilwoman Monica Mayer the issue at hand is there was blood work drawn and there wasn't follow up with the patient and now its life threatening. Councilwoman Monica Mayer asked Melissa Brady to look into this.

F. Circle of Life – *Bruce Gillette*

Mr. Gillette notified the Committee that there are 3 applicants for the Director's position. Budget for the year stayed the same. We have 4 tribal members in treatment at Native American Connections and 6 in the referral process. There is a 3 week wait because they are full. We have 7 tribal members that completed treatment so far. We have had 20 referrals since November 2016. The travel comes out of the Chairman's budget for the applicants for the 45 day treatment services. Since November, Chairman has payed around \$68,000 for Nov.- Mar. Boon Insurance

is starting to help with cost. \$195.00/day for a 45 day treatment. Mr. Gillette recommended securing services from Volunteers of America (WY.) for the 90-day treatment. The Circle of Life gets an IHS budget (\$415,404) and hasn't received funding from the tribe in two years. The Committee emphasized the need to support the Circle of Life program. Mr. Gillette will notify Boon Insurance that Volunteers of America is the cheapest. \$150,750 for 10 people to the end of budget year. Al Nygard will try and move some budget funds for this. Councilman Fred Fox expressed the need for additional data collection and patient tracking to verify what works. Bruce Gillette noted that if they don't seek after-care the program losses the ability to track their progress. It's up to the individual whether they want to continue further after treatment. Councilwoman Monica Mayer said there is a 15% chance of success after treatment, we need after care and not just a focus on treatment and requested continued data collection. Al Nygard said it was the prioritization of the budget cuts. They come out of recommendations from the committees, and the tribal council. Bruce Gillette noted that when dealing with mental illness we have no teeth to help them to change their lives and without additional budget & staff we can't track them. We have overdoses all the time and there is nothing we can do. Councilwoman Monica Mayer states we just need to give Boon/Tribal Care Insurance a directive to assist with this along with the courts or judges to mandate. The health care cost is exponential and I would be willing to sit on a committee for treatment after care. Mr. Gillette not that probation is shorthanded so there are problems with follow up there. Councilwoman Monica Mayer recommended a task force and develop a strategic plan. Mr. Gillette noted that there has to collaboration within the various agencies.

G. KDU - Callie Baker

May 2017 Report submitted. We are still looking for another nurse but have an applicant. They are starting repairs on the basement at the KDU building. We have been getting reimbursements from Boon. Housing is still an issue for staff. I need a house for our social worker. Maintenance Dept. has received a number of directives to rehabilitate the three houses. Al Nygard discussed the insubordination, suspension and termination problems and revisiting 93-033- JJR. Of the 10 units at the Minni Tohe, 7 are currently occupied. Councilwoman Monica Mayer believes health care workers should have those houses not tribal workers. Mr. Nygard has requested additional funding without reply. Callie Baker noted that there is \$90,000 in our budget for this and nothing has happened. I have worked on getting the bids to get the house done since last September. Mr. Nygard recommended polling the federal and indirect funds and secure a bid with a contract. Councilwoman Monica Mayer asked Mr. Nygard to draft a letter of request for the I.H.S. maintenance funding for the Council to sign. Callie Baker and Al Nygard to select a bid.

Motion: Councilwoman Monica Mayer moved to forward I.H.S Housing Rehabilitation Contract to the June Tribal Business Council subject to legal review. Councilman Fred Fox seconded the motion. Vote: 3-0-0. Motion carried.

Discussion: We have 20 patients and have 10 chairs. We hired 10 out of 11 nurses. Councilman Frank Grady offered use of one of his emergency housing trailers as temporary housing for the staff. Have met with the Chairman's planning work group for the new KDU facility.
