C. FBRW Report - Camilla Gosnell

RFQ was advertised according to federal regulations for 21 days. Seeking approval of SEH as the highest ranked RFQ out of 4 submissions for an Engineer for FBRW systems and plant facilities. Camilla Gosnell provided an overview of issues in the system.

Camille Gosnell note that those submitting bids are; SHE, Bartlett & West, White Shield and AE2S. CEO recommended a stay for further review.
