D. Juvenile Detention - Mike Young Bird, Administrator
45 inmates released from the Justice Center in June and July. We have had five
forensic interviews. We have programmatically tracked 25 youth for June and July.
There are 6 individuals in detention currently. Average offence is usually drugs,
DLC's, and MIC's.

E. Child Support Enforcement - Ellen Otterman, Director

Ellen Otterman provided an update and hand out. The program currently has one vacancy that is being advertised. Region 8 Federal Representatives provided an onsite visit and review of 25 inter-jurisdictional cases. Monthly meetings are continuing. We are using Quick Books and CIS database software are both currently utilized for data collection. Revenue is at \$1,000,058. We are getting many cases have been referred to us from the state. 698 open cases and many transfer cases from the State.
