Request for Life & Limb. Daughter sustained injury from an accident the occurred at the Earth Lodge Village on September 16th, 2016. 1.3 million bill. Received \$500 from grants and donations, and other segments helped out. All together about \$1,200. My daughter has to go to therapy every 2 weeks. I am currently behind on my bills and have to travel to Rapid City to see an eye specialist. Medicaid covered everything so far. Valor Insurance is involved but haven't received anything from them yet. They can go back 6 months from the day that the claim was approved. Ms. Hosie is in arrears for her rent by a couple thousand dollars.


