Mr. Wells stated they have been able to verify 8 years with the Commodity Program and North East Segment Security, about a 25 years for \$20,000.

record for overall State Championships and attaining national ranking. Also commended the Veteran's Day activities and the culmination of the 30-day Sacred Fire Prayer Vigil.

Chairman Mark N. Fox recommended



talking to wholesalers and determine the reason for their failure to provide services and review their concerns even after revisions of the code. Cynthia Monteau noted that the Casino has over a million a year in alcohol sales. Chairman Mark N. Fox expressed concern over outside wholesalers who have made millions from the reservation and now refuse to provide services when we assert our jurisdiction.

## • Authority to Apply for Wholesalers Sales

## Oil & Gas Update

The 2016 Assessment includes about 30 companies with over half that have filed informal assessment review with nine formal appeals to the Tax Commission. Administrative Judge. Contract amended to include duties to hear the appeals and resolve prior to the formal appeal. Staff will be reaching out to the extraction payers to get list of their contributions to develop tax credits for their investments in the MHA Nation.

Lisa Lone Fight, TERO Commission noted that she supports the recodification. Changes remove duplication, grading services, application process, preference to those with "skin in the game", Capital Leasing, and differences between Oil & Gas and construction. Chairman Mark N. Fox expressed that the Tribal Business Council has been concerned with "fronting" and insuring tribal companies are getting work from the larger companies, thus the need for changes in the code. The Code has gone from 12 pages from 33. The Commission will have emergency regulatory authority. Chairman Mark N. Fox expressed concern that the portion on Indian Preference of 51% under the ordinance. Mr. Soderstrom noted that it gets addressed under the regulations. Chairman Mark N. Fox reminded the group that that it has to be approved by the Tribal Business Council. Councilman Randy Phelan expressed his concern that the Indian contractors had input on the changes. Lisa Lone Fight confirmed that they have received their input through a number of venues.
