A. Elders Organization – Thomas Eagle, Ramona Two Shields, Donna Morgan Brought forth concerns of physical records taken from the Fort Berthold Agency to the Lakewood CO. Office. The group is asking for the return of the records to the New Town BIA Office. There most concerned with the allottee records and would like to see an official resolution from the Tribal Business Council keeping the records at the local agency. The group has submitted letters to various levels of the Federal government laying out their concerns. Chairman Mark N. Fox provided a summary of work on the Communitization (CA's) process and his concerns on the idea of a CA and royalties. The group expressed their concerns on the removal of records and not receiving notice that the records were to be moved. Councilman Fred Fox expressed his commitment to keeping these services and others that have moved to the regional level in Fort Berthold and the need for face to face service in the need for infomation. Tim LaPoint (Great Plain Regional Director) and Carla Clark (Indian Service Center) presented information on the CA process. Before the Service Center was extablished there was a back-log (from 2008) and 19 CA's were transferred to the Service Center to free up to do other things. All the documents are shared and are in the TAAMS systms. Carla Clark noted that the Center processed 37 of the back-log of 182 and that the original records will be returned to New Town. Tim Lapointe noted that a Petroleum Engineer has been found to assist at the Center and at the Fort Berthold Agency. The Center has set up a toll free number to improve communication and increased access to informational services.

*Motion:* Councilman Randy Phelan moved to have the 19 CA's records returned to the Fort Berthold Agency immediately. Councilman Frank Grady seconded the motion.

#### 4) Special Diabetes Project Initiative (SDPI) - Jared Eagle

Discussed program funding problems and the need to lobby for additional funding due to the current legislative bill being attached to the CHIPS bill with a funding level of 25% (\$155,000) of this year's funding. #### I. Doradus Hotel Group Opportunity – Terry Bynum

Seeking expansion of their tribes' (Porch Band of Creek Indians) economic investments through hotels & entertainment by limited partnership. The Group is affiliated with Marriot and Disney within the mid-market. Shakopee and Pechanga are other tribes expressing interest have secured commitment for about \$60 million. Investment would be spread throughout a number of their projects to lesson risk. Disney (Florida) has sold land to the group to develop next to their main venue with a planed retail development around the property. The capital would be stretched over



an 18-month period to get the project completed and operate the business for about five years and then sell it. No Letter of Intent would be needed at this time. The group has invited the Tribal Business Council to meet with them and tour the locations and have further discussion.
