Researching lumber estimates—Dismantled and just the frame was destroyed and outside is still intact. Alton Spotted Horse was there as well as Jay Standish: Turned in fire report to Valor Insurance. Jay tried to put out fire with fire Extinguishers. Life Expectancy of Lodges is about 10 years. Looking for funding because the budget does not cover the cost to maintain. Front entrance cement repaired, restructured and maintained. Tourism budget is 13% is spent to date.
