5) Lease Rental Overpayment – John Fredericks, Attorney

Bureau of Indian Affairs is proposing to restrict Individual Indian Monies (IIM) Account number 301T301052 because an overpayment of \$942.20 was issued to the Three Affiliated Tribes and to which the Three Affiliated Tribes was not entitled. Oil & Gas Lease 301-7420A4907 4 allotment 301-MT1847 (89.95 acres), was originally leased to Marathon, effective February 8, 2008 and expires on February 7, 2013. This lease contained the following described lands; Section 11, Tl52N, R93W (Lot 5, 14.26 acres, Lot 9, 31.36) acres), Section 14, TI52N, R93W (Lot 2, 26.11 acres), Section 27, T152N, R93W (Lot 2, 18.22 acres). Rental over payment on a portion of this lease was due to segregation of the lease upon approval of Communitization Agreement NDM-101124 (CA), which included only Lot 2 of Section 27, T152N, R93W. The portions segregated out of the base lease are described as Lots 5 and 9 of Section 11, TIS2N, R93W (45.62 acres) and Lot 2 of Section 14, TIS2N. R93W (26.11 acres). The remaining base lease (7420A49074) acreage in Lot 2 of Section 27, Tl52N. R93W is 18.22 acres and is held by production. Production was not established in Sections 11 and 14 and these portions of the segregated lease expired on February 7, 2013. The lessee continued to incorrectly pay for the entire tract acreage, 89.95 acres which created this over payment. The 71.73 acres in sections 11 and 14 are unleased and no rental payments are due. The DOJ recommends just paying due to allow them to proceed with a lease compliance issue with Marathon. Recommends paying the uncontested amount.
