Committee states if companies won't abide, we will start pulling their TERO cards. We will send out a notice first and if you don't comply we will address you at full Council. Committee address directors and oil companies need to inform council in their communities, produced water in Four Bears Segment. Councilman Frank Grady was the last to know about what's going on in Four Bears Segment. Good Night Diamond PTS. Carson Hood Jr., we get them signed after the community board approved it. Councilman Frank Grady states there will be a resolution for no produced water pipeline in Four Bears Segment.
