D. Goldman-Sachs Investment – Bill Lomax, VP & Izu Akamiro

Presented an economic and market review, investment themes, tactical views, forecasts & valuations, and portfolio positioning & performance. Beta+ strategy performance. Only 10% change of recession in the U.S. which is considered very low over the next two years. Predicts that the Mid-term elections will produce a flip the House. The presenter does not expect a trade war with China at this time. Oil has hit the highest in three years with WTI





possibly rising to the \$76 – \$77 range in the next three months considering the Iran situation that may push it higher. Councilman Randy Phelan believes it could go to \$80/barrel level. The presenter does not belief alternative fuels will effect long-term oil production & demand. Over-supply poses the greatest threat to revenue at this time. Risks are mostly global; U.S Treasury yields are expected to cause rising interest rates. Close to 9% return with the current strategies. Submitted a written report to the Council of the TAT Portfolio. Returns from the portfolio are at about \$3.815 million to the MHA Nation. Year end expectation of a 5% increase and believes the portfolio are very well positioned. Chairman Mark N. Fox noted that earnings would be at 3-4% if held with the Federal government. The Tribe must have higher earnings and it would be the responsibility of Goldman-Sachs to make gradual adjustments to management risk. Any significant change in the portfolio would requires approval of the Chairman.

E. JTAC Investment Portfolio - Gerald V. Tamparong & Frank F. Spindler - Payden & Rygel Currently \$34 million invested. Portfolio has shown about \$10 million in return since the start of the investment in July 2013. There is a 7.5% annual return on the current plan. Councilman Mervin Packineau noted that gains may not be seen as advantageous in the coming year. Yearly average gains for this portfolio are at 6.7%.

3) Tax Department Report – Cynthia Monteau, Tax Commission Director
Submitted a report and final comments on the State Data and Riverbed Extraction Tax.
March is the 6th month of Fiscal Year 2018 (FY'18). All monthly revenue collections (at the time of this report) are \$17,409,749.78. Overall collections for the month of March are lower [\$3,550,173.94] than February and \$1,202,443.84 lower than the monthly average for FY'18. The monthly average collected for the past 6 months is \$18,632,164.67, for a total amount collected in FY'18 of \$111,792,987.99. Oil production and extraction make up about 87.9% of the revenue collections for FY'18. A 5-year (FY'14-FY'18) Monthly Revenue Collections Comparison for the month of March, shows March 2018 is the second to highest month for collections, behind February 2014. A 5-





year (FY'14-FY'18) Annual Revenue Collections Comparison shows that current collections are at 77% of FY'17 and 41% of FY'14, respectively. FY'14 was the highest year of annual revenue collections over the past 5-years. The monthly average collected for the past 6 months (Oct-Apr) of Drilling Fees (at the time of this report) is \$1,785,714. March and April collections were both at \$1,500,000. Drilling Fees for FY'18 (Oct-Apr), are at 95% of the FY'17 total annual Drilling Fee collections. Rick Grant was introduced as the Tax Dept. IT. & will be maintaining the Web-based Tax accounting system to help with the collection of taxes.

B. Tribal Court Report - Marvel Heart & Elizabeth Yellow Bird Submitted a written Report. FBDC has 32 positions funded by the court and TAT Legal budgets. FBDC currently (as of 5-4-1 8) has 18 full time employees and 14 vacancies, the vacancies are: 1 Chief Judge, 3 Bailiffs, 1 Assistant Prosecutor, 1 Public Defender, 1 Public Defender Clerk, 3 Deputy Clerks, 1 Receptionist, 1 JV Officer, 1 Adult Probations Officer and one Accounts Manager. We have selected the 3 Deputy Clerks, the Public Defender Clerk and the Receptionist and are completing the documentation for hires. FBDC will interview and hire the Probation Officers, May 7-11th. Therefore, by May 11th the FBDC will have 25 full time employees. The Chief Judge, Assistant Prosecutor and Public Defender positions are under the Legal department authority. A Public Defender has been hired for 30 days and until approved by TBC. Sara Robinson continues to get her office area set up; Prosecutor Ackre has expressed support for Sara and that it will be a good adjustment. A c Clerk has been selected for the Public Defender's office. The court has momentarily stopped sending out letters while we catch up on paperwork. The Justice Commission had a good meeting on April 13; minutes attached in administration section of the monthly report, the Court and the Justice Commission have begun to work together on strategic planning for FBDC. The Court hired Deb Simonson to conduct clerk training April 30th - May 3rd, 2018. Clerks attended "Clerks Conference" training in Bismarck, May 3rd-4th. The court is submitting for your information the Court Building architects 'Field Report that lists all the building construction concerns that need to be resolved.
