The show will showcase designers from across Indian Country and being cohosted by the United Tribes Technical College. Budget amount \$8,548.00. Have raised \$2,000 to date, the \$8,548 requested is outside the amount raised.

Ordered material for the lodge and will be working on that project soon. Have youth workers working. Salary modification or title change for James Moran presented. Committee asked to make sure to send it through HR first. Darian states that it won't be ready until August TBC. Committee asked to have CEO speak to Chairman to have entities collaborate more.


