Restorative Justice Pilot Program – *Nikos Valance & Caleb Dog Eagle, Lead Attorney* Project to develop and implement two parallel pilot projects employing restorative justice practices and incorporating indigenous culture. Nationally, only practiced at the juvenile level. Seeking \$25,000 and have sent proposals to oil companies. Have met with the State. \$150,000 total budget for the first year. One project on Fort Berthold with coordination initially by Nikos Valance with a transition to a management team. Chairman Mark N. Fox requested an entity be established for oversight. Caleb Dog Eagle recommended the Legal Dept. and the Court. Al Nygard, CEO recommended contribution be contingent on securing other additional funding sources to reach the needed \$150,000. Councilman Randy Phelan wants insurance that the data proprietary concerns are addresses to protect the tribe.

3) Tax Department Report – Cynthia Monteau, Tax Commission Director Report submitted. July is the 10th month of Fiscal Year 2018 (FY'18). OPT and OET collections are not included in July because they have not been reported, therefore, July's collections without actual oil and gas revenue are estimated at \$21,702.796.93. A 5-year (FY'14-FY'18) Monthly Revenue Collections comparison for the month of July, shows the estimated month of July is the second highest month for collections. Actual July oil and gas collections will be reported in mid-August. A 5-year (FY'14-FY'18) Annual Revenue Collections Comparison shows that current estimated FY'18 revenue collections have surpassed FY'17 by approximately \$54,760,228.70. FY'14 was the highest year of annual revenue collections over the past 5 years at over \$270 million. The total amount of Drilling Fees Collected for the past 10 months (Oct-July) (at the time of this report) is \$18,100,000, with the monthly average of \$1,810,000. June was the lowest month collected at \$200,000 and May was the highest at \$4,000,000. Drilling Fees for FY'18 (Oct-July), are \$5 million higher than the total annual fees collected in FY'17.
