#### A. N. LB. - Dental

Patient requested assistance with dental work. Had a crown done and need more work. Boon Insurance covered some of the bill. Patient owes \$1,974.50. Councilwoman Monica Mayer asked if she went to TAT Dental. They don't work with partials, and they didn't refer out. Pam states, Boon Insurance only covers dental if it is an injury. Major services is 50/50. Councilwoman Monica Mayer suggested having Pam and patient work with FLC Dental. Need to negotiate the bill down. Will need to forward to TBC.

Program update. Policies and procedures hand book update. Served 584 individuals so far. Working with other programs. We are certified to do drug and alcohol testing. Have some clients currently, and have some applicants who just applied.
