Submitted a business proposal to provide home health care services in the Bismarck/Mandan area to Elder's and the disabled that are homebound and unable to care for themselves and those who have been discharged from the hospital and need continued assistance.



The State of North Dakota requires licensing for home health care, and our application is pending. Our plan of operation is to assist 80 clients in the Bismarck/Mandan area, three hours/day, and four days a week. This will provide for twelve hours a week for billing for each client. Our revenue is based on an initial cost of \$78.50/hour, or \$942.00 a week per patient. Source of revenue is based on private pay, Medicaid, Medicare, and other insurance carriers. The major cost of operation will be the professional staff consisting of Registered Nurses, Licensed Practical Nurses, Personal Care Attendant, Licensed Social Worker, Business Manager, and a Secretary. Seeking seed money or a grant. Cash flow plan of \$100,000. Dr. Kathy Eagle noted that she has seen a need and would build a team of nurses. Chairman Mark N.
