*Motion:* Councilman Fred Fox moved to approve the October 6<sup>th</sup>, 2020 Health & Human Resource Committee Minutes. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

#### V. <u>NEW BUSINESS:</u>

#### A. Medical Bill - Nancy Meyers

Nancy Meyers phone conferenced in from Colorado to request medical assistance with bills from 2020. Diagnosed with arthritis in hips and need right hip replaced following the left hip. Has been getting stem exosomes. She is 53 and feels too young to have these health issues. Had COVID and afterwards her hips started hurting. 85% recovery from the stem exosomes treatment. Hired a trainer to work on muscles to learn how to move right hip better. On December 10<sup>th</sup> she will go through another round of stem treatment. Seeking assistance in the amount of \$16,500 for the next round of stem cell treatment. Trainer cost \$320.00 per month, 2 months total. Will go to \$180.00 per month in December. Medicine cost \$321.00 for August and \$321.00 for October. Requesting \$21,000 total for all treatment, cell treatment, trainer and medicine. For the first round of stem cell treatment Tribal-Care paid for most of the bill & Nancy took care of the rest. Even if she could get the stem cell treatment covered she would even be willing to cover the rest. Boon is an insurance company that covers experimental treatment, Blue Cross Blue Shield does not. Will do the treatment at the Aspen Institute Ani-aging & Regenerative Medicine.

*Motion:* Councilman Fred Fox moved to forward (\$16,500 request) to TBC. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

#### B. Medical Bill – Richard Hosie

Mr. Hosie has an outstanding bill, he was referred out. He went to Stanford for the ACL surgery that cost \$28,496.02 from 2015-2016. The bill was turned into Contract Health and he was told



they would not pay since he lives off the reservation, but at the time of referral he lived in Mandaree. Fawn with Contract Health states it will get paid within about 2 weeks. Councilwoman Monica Mayer asked Richard Hosie to call her office when the bill is taken care of. Kathy Eagle states the patient has to apply for alternate sources such as Medicaid first. Councilwoman Monica Mayer thinks we should have a Tribal Health Committee/Department.

### C. Medical Bill – Gilbert Packineau

Was looked at the last committee meeting, since the bill is older he can't be covered back. He filled out paperwork and was denied, Pam Lewis of Tribal-Care will negotiate the bill down. \$18,252.93 overdue bill. Gilbert fell and hit his head and lives off the reservation and went to another IHS and was denied since he did not live on their reservation. He is signed up with Tribal Care now.

*Motion:* Councilman Fred Fox moved to forward to TBC. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

A. Elbowoods Memorial Health Center (EMHC) - Kathryn R. Eagle-Williams, MD MPH, CEO Working on setting up COVID testing for TAT staff in December. 110 active COVID cases currently on Fort Berthold. There are two vaccines almost ready, Moderna and Pfizer. Will store whatever they send us. Could have the vaccine by mid to late December. The Grant was extended due to COVID. Councilwoman Monica Mayer if Mr. Packineau was denied at another tribe, they probably have a resolution to keep their PRC monies only to their tribal members. Kathy Eagle would like to have a meeting regarding PRC. PRC grant monies are spent down since the last two years.

Presented Draft Contract renewal for Davis Emmons, Nurse Practitioner.

*Motion:* Councilman Fred Fox moved to forward Draft Contract renewal for Davis Emmons to TBC. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

Contract renewal for Dr. Slann Podiatrist. \$2,400.83 per day. The CEO would like him here two days a week. Contract not to exceed \$50,000.
