



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

***A Resolution Entitled: "Approval of Amended Fiscal Year 2021 General Fund Budget for the Three Affiliated Tribes."***

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes (or "Tribes") generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies; and

**WHEREAS,** Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to administer any funds or property within the exclusive control of Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and

**WHEREAS,** The Tribal Business Council has the authority and is required by law to adopt an Annual General Fund Operating Budget each Fiscal Year in order to appropriate and expend its federal and general funds; and

**WHEREAS,** The Tribes operate on a Fiscal Year which began for 2021 on October 1<sup>st</sup> 2020 and ends on September 30<sup>th</sup>, 2021; and

**WHEREAS,** The Tribal Business Council has authority and is required by law to adopt an Annual General Fund operating Budget each fiscal year in order to appropriate and expend its federal and general funds, and such Budget was set forth in Resolution No. 20-194-FWF which is hereby amended; and

**WHEREAS,** A FY-2021 General Fund operating budget in the amount of \$150,335,000 has been formulated, and the Tribal Business Council has reviewed and approved said budget; and



**WHEREAS,** A FY-2021 Special Projects budget in the amount of \$172,095,000 has been formulated and approved by the Tribal Business Council; and

**WHEREAS,** A FY-2021 Investments budget in the amount of \$63,600,000 has been formulated and approved by the Tribal Business Council; and

**WHEREAS,** A FY-2021 Disbursements budget in the amount of \$50,250,000 has been formulated and approved by the Tribal Business Council; and

**WHEREAS,** A FY-2021 Segment Operating and Development budget in the amount of \$42,000,000 has been formulated and approved by the Tribal Business Council; and

**WHEREAS,** The Tribal Business Council concurs with the Treasurer that deficit spending during fiscal year 2021 should be strictly prohibited and that internal controls will be used to ensure deficit spending does not occur and approved budgets are not exceed.

**NOW, THEREFORE, BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby approves and adopts the following FY 2021 General Fund Operating Budget in the amount of \$150,355,000; the FY 2021 Special Projects Budget in the amount of \$172,095,000; the FY 2021 Investments Budget of \$63,600,000; the FY 2021 Disbursements Budget of \$50,250,000; and the FY2021 Segment Operating and Development Budget of \$42,000,000; and

**BE IT FURTHER RESOLVED,**

1. That internal controls shall be strictly enforced to ensure that deficit spending does not occur in FY 2021; and
2. TAT Finance, Contracts and Property Departments shall notify the budget administrators when they have reached 90% of their 2021 fiscal year budget allocation; and
3. TAT Finance, Contracts, and Property Departments shall not process any documentation and/or purchase orders for General Fund Programs or Special Projects that have exceeded their budgets and shall require program modifications (consistent with the approved budgets for the individual line item budget change); and
4. The TAT CEO and CFO shall have administrative authority to adjust program budgets within the General Fund Operating budget and Special Projects budget as necessary to facilitate the functioning of the programs to best serve the needs of the Three Affiliated Tribes, and the FY 2021 overall budget shall be subject to further revisions by Tribal Business Council as necessary; and

**BE IT FINALLY RESOLVED** that the budgets established and approved by this Resolution



shall not be modified or amended without further formal resolution of the Tribal Business Council of the Three Affiliated Tribes.


**CERTIFICATION**


