



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled “Amending Resolution 20-215-FWF - Eden Atkins ROW.”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act; and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation (“Tribes” or “MHA Nation”), the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

WHEREAS, Article IX, Sections 1 and 3 of the Constitution provide that the Tribal Business Council has the authority to manage and lease or otherwise deal with Tribal lands and resources; and

WHEREAS, Leases and Rights of Way (ROWs) across Tribal trust and fee land require the consent of the Tribal Business Council pursuant to federal and Tribal law; and

WHEREAS, The United States Department of the Interior, Bureau of Reclamation (or “BOR”) provides funding for the Fort Berthold Rural Water Supply system (or “FBRW”) to aid the MHA Nation in providing safe drinking water to its members throughout the Fort Berthold Indian Reservation; and

WHEREAS, The FBRW is operated by the MHA Nation pursuant to a contract under the Indian Self-Determination and Education Assistance Act, which requires rights of way (or “ROWs”) for FBRW purposes to be granted to the BOR as the acquiring federal agency while the project is federally funded; and

WHEREAS, ROWs for FBRW rural water line subuser connection in association for Eden Atkins were previously granted pursuant to Resolution No. 20-215-FWF; and

WHEREAS, This Resolution amends Resolution 20-215-FWF with the updated pipeline route in T5216 shown on Appendix A.1 and adds a new Tract T2059 shown on A.2 due to a reroute around a refusal on an allotment; and



WHEREAS, The Tribal Business Council finds it appropriate to authorize the amended ROW, described herein in the West Segment for a rural water line connection for Eden Atkins, and to waive the provisions for payment and bond in consideration of the public benefit that the FBRW system provides.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby consents to the following ROW(s) to the United States Department of Interior (acquiring agency BOR) and its assigns for the construction, operation, maintenance, and replacement of the FBRW system:

1. Tribal Tract T5216 in Section 16, Township 150 North, Range 94 West, McKenzie County, 5th Principal Meridian of North Dakota, containing a 1.0000000000 share, as more particularly described in Appendix A.1; and
2. Tribal Tract T2059 in Section 16, Township 150 North, Range 94 West, McKenzie County, 5th Principal Meridian of North Dakota, containing a 1.0000000000 share, as more particularly described in Appendix A.2; and

BE IT FURTHER RESOLVED, that the term of the ROW(s) shall be perpetual (subject to termination in accordance with applicable federal regulations), and the requirements for compensation and bond are hereby waived; and

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.







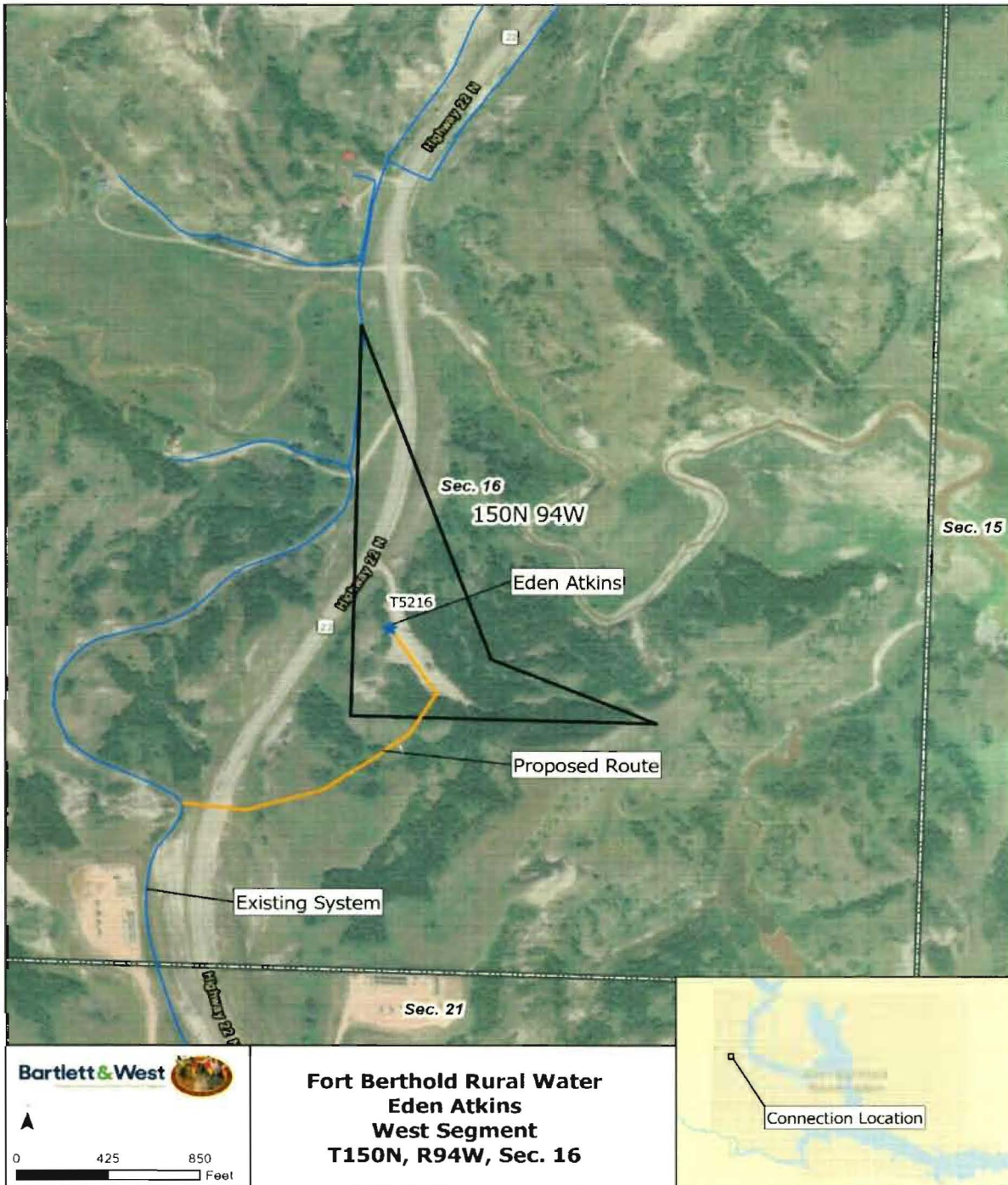
