



Resolution No. 22-173-FWF

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby authorizes and directs the Tribal Finance Department to pay each and every living Tribal member who is an elder, as defined above, a financial disbursement in the amount of \$2,500 to be distributed on or about December 2021 and \$3,000 to be distributed on or about July 2022 as part of Tribal elderly living assistance; and

BE IT FINALLY RESOLVED, that such disbursements will be paid from available income derived from the Tribes' trust lands and income in accordance with Resolution #03-186-RP.

**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled “Amending Resolution 21-271-FWF which provides Authorization for Disbursement to the Elders”.

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

WHEREAS, Pursuant to Article III., Section 1 of the Constitution of the Three Affiliated Tribes (or “Tribes”) provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, This Resolution amends Resolution 21-271-FWF which provides for elder disbursements in December 2021 and July 2022; and

WHEREAS, An elder is defined as an enrolled Tribal member who is 60 years of age or older by December 31, 2021 for the December 2021 disbursement and 60 years of age or older by July 31st, 2022 for the July 2022 disbursement, and has substantial medical or other needs which are not being met through existing programs of assistance; and

WHEREAS, The Tribal Business Council desires to do what it can to help meet the needs of Tribal elders; and

WHEREAS, There are available sufficient Tribal Funds in the Fiscal Year 2022 budget to permit each elder to receive an elderly assistance grant in the amount \$2,500 for health care and other needs of each and every Tribal elder in December 2021 and \$3,000 in July 2022; and

WHEREAS, The Tribal Business Council desires to have these funds distributed from the Docket Funds and/or income derived from the Tribe’s lands in accordance with Resolution #03-186-RP.
