RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

A Resolution entitled, "Approval of Continuing Resolution For FY 2023 General Fund Budget Expenditures Based Upon 90% of FY 2022 General Fund Budget."

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation (or "Tribes"), authorizes and empowers the Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business to administer funds within the exclusive control of the Tribes and to make expenditures from available funds for the public purpose of the Tribes; and

WHEREAS, The Tribal Business Council adopts a budget for every fiscal year; and

WHEREAS, The Tribal Business Council is currently working on finalizing a FY 2023 General Fund Budget; and

WHEREAS, The Tribal Business Council fully believes that it is in the best interests of the Three Affiliated Tribes to develop a FY 2023 budget that is fiscally responsible and meets the needs of the Tribes and its members; and

WHEREAS, The Tribal Business Council desires to continue to operate under the FY 2022 budget until such time as it may carefully consider and adopt an FY 2023 Budget.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves expenditures at 90% of FY 2022 levels as reflected in the FY 2022 budget until such time the Tribal Business Council approves a budget for FY 2023
