



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

***A Resolution Entitled: “Approval and Authorization of Fort Berthold Rural Water to Proceed with South Segment Water storage capacity upgrade, Not to Exceed \$5,000,000.00 for the Immediate Needs of the South Segment and The Three Affiliated Tribes.”***

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

**WHEREAS,** Pursuant to Article III, Section 1 of Constitution and By Laws of the Three Affiliated Tribes (or “Tribes”), the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Pursuant to Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to expenditure from available Tribal funds for public purposes of the Three Affiliated Tribes of the Fort Berthold Indian Reservation; and

**WHEREAS,** Pursuant to Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials of the Reservation; and

**WHEREAS,** The Tribes have completed numerous Economic Development Enterprises and Tribal Government Buildings within the South Segment Master Plan along with Future Planned Residential and Commercial Development; and

**WHEREAS,** Fort Berthold Rural Water has also informed the Tribal Business Council of the immediate needs of the South Segment Water Intake and the need for expansion and upgrade, since it has reached its holding fresh surface treated water capacity; and

**WHEREAS,** The Fort Berthold Rural Water System Master Plan of August 2021 provides that upgrades and system expansions are deemed paramount for the South Segment of the Fort Berthold Indian Reservation.

**NOW, THEREFORE, BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby approves of the development and construction of a new Fresh Water 500,000 Gallon Storage tank; and



**Resolution No. 23-071-FWF**

**BE IT FURTHER RESOLVED**, that the Tribal Business Council hereby authorizes and approves the South Segment Water Storage Tank expansion in the amount not to exceed \$5,000,000.00, for the Design, Construction, Access and Right of Way to be completed in accordance with the following construction schedule:

- FY2023- \$1,500,000.00
  - 500,000-Gallon Storage Tank design, Geotechnical, Bidding and Initial construction
- FY2024- \$3,500,000.00
  - 500,000-Gallon Storage Tank construction completion; and

**BE IT FURTHER RESOLVED**, that such 500,000-thousand-gallon storage tank is to be budgeted over FY 2023 and FY 2024 from the Tribes' General Fund budget, contingent on available funding and taking into consideration the many needs and responsibilities of the Tribal Business Council and other burdens on the General Fund, including emergency situations that affect the fund; and

**BE IT FURTHER RESOLVED**, that the aforementioned development and construction shall comply with all applicable laws and regulations of the Three Affiliated Tribes; and

**BE IT FINALLY RESOLVED**, that the Tribal Chairman, pending legal review, is authorized to execute the documents necessary to carry out the terms and intent of this Resolution.


**CERTIFICATION**
