



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

***A Resolution entitled, “Approving Amendment To Targa Biglake Agreement”***

**WHEREAS,** The Mandan Hidatsa and Arikara Nation (the “Nation”), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the “Constitution”) under said Act, and

**WHEREAS,** Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

**WHEREAS,** Article IX, Sections 1 and 3 of the Constitution, provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and

**WHEREAS,** Article VI, Section 5(c) of the Constitution specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Nation and to make expenditures from available Tribal funds for public purposes for the Nation; and

**WHEREAS,** The Tribe previously entered into an agreement with Targa Resources and tribal member Bobbi Biglake regarding the relocations of Ms. Biglake’s home (Agreement); and

**WHEREAS,** An amendment to the Agreement has been proposed; and

**WHEREAS,** The purpose of the amendment is for Targa to cover additional costs related to the relocation and contingencies if the home is not relocated in a timely manner; and

**WHEREAS,** The Tribe has reviewed the amendment and finds it acceptable.

**NOW THEREFORE BE IT RESOLVED,** That the Tribal Business Council approves the amendment and authorizes the Tribal Chairman to execute the same.

**BE IT FINALLY RESOLVED,** The Tribal Chairman is hereby authorized to take such further action as are deemed necessary to carry out the terms and intent of this resolution;



**CERTIFICATION**
