



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled: "Land Purchase – Heidi Hernandez, West Segment."

WHEREAS, The Mandan Hidatsa and Arikara Nation, also known as the Three Affiliated Tribes ("MHA Nation" or "Tribes"), having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the Constitution) under said Act, and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and

WHEREAS, The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and

WHEREAS, Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Business Council, its agencies, and officials; and

WHEREAS, The Three Affiliated Tribes has determined that it is in the best interest of the Tribes to acquire land; and

WHEREAS, The Tribal Business Council has considered the location of the below-described land, the potential public and economically beneficial use of the land, and Tribal Self-determination; and

WHEREAS, After such consideration the Tribal Business Council approves the purchase of said land, subject to the drafting of appurtenant legal documentation.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves the purchase of the surface described below from:

Heidi Hernandez, Tribal Member

For cash consideration of \$20,576.79, which is the appraised value, utilizing funds from FY2023 560 Land Purchase Account, and hereby authorizes the Chairman of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of the Indian Affairs to prepare all documents and do all things necessary to transfer title of the land to the United States of America, in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit:

Allotment 301-1067A, S½N½, N½S½, Section 32, Township 148 North, Range 94 West, Dunn County, 5th PM of North Dakota, 320-acre tract, containing an undivided 0.0203703704 interest, appraised at a value of \$5,671.11.



Allotment 301-1068A, SW¼, Section 28; NW¼, Section 33, Township 148 North, Range 94 West, Dunn County, 5th PM of North Dakota, 320-acre tract, containing an undivided 0.0475308642 interest, appraised at a value of \$14,905.68.

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents, pursuant to legal review, and take such further actions as are necessary to carry out the terms and intent of this Resolution.


