

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution entitled, "Consent to Certain Right(s) of Way across Tribal land."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act; and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation ("Tribes" or "MHA Nation"), the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX, Sections 1 and 3 of the Constitution provide that the Tribal Business Council has the authority to manage and lease or otherwise deal with Tribal lands and resources; and
- WHEREAS, Leases and Rights of Way (or "ROWs") across Tribal trust and fee land require the consent of the Tribal Business Council pursuant to federal and Tribal law; and
- WHEREAS, The United States Department of the Interior, Bureau of Reclamation (or "BOR") provides funding for the Fort Berthold Rural Water Supply system (or "FBRW") to aid the MHA Nation in providing safe drinking water to its members throughout the Fort Berthold Indian Reservation; and
- WHEREAS, The FBRW is operated by the MHA Nation pursuant to a contract under the Indian Self-Determination and Education Assistance Act, which requires ROWs for FBRW purposes to be granted to the BOR as the acquiring federal agency while the project is federally funded; and
- WHEREAS, The MHA Nation's processing fee for this ROW assignment application is \$100.00 per Allotment Number, equaling \$700.00; and
- WHEREAS, The application(s) for ROW(s) described herein have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal land; and



- WHEREAS, The Tribal Business Council finds it appropriate to authorize a ROW in the West Segment for an Access Road for the Mandaree Water Treatment Plant and Intake described herein, and to waive the provisions for payment and bond in consideration of the public benefit that the FBRW system provides.
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby consents to the following ROW(s) to the United States Department of Interior (acquiring agency BOR) and its assigns for the construction, operation, maintenance, and replacement of the FBRW system:
  - 1. Allotment 1083A of Section 34, Township 150 North, Range 94 West, McKenzie County, 5<sup>th</sup> Principal Meridian of North Dakota, containing a .8577546295 share, as more particularly described in Appendix A. 1; and
  - 2. Allotment 1082A of Section 35, Township 150 North, Range 94 West, McKenzie County, 5th Principal Meridian of North Dakota, containing a .6934027777 share, as more particularly described in Appendix A. 1; and
  - 3. Tribal Tract T1788 of Section 36, Township 150 North, Range 94 West, McKenzie County, 5th Principal Meridian of North Dakota, containing a 1.0000000000 share, as more particularly described in Appendix A. 1; and
  - 4. Tribal Tract T1725 of Section 25, Township 150 North, Range 94 West, McKenzie County, 5th Principal Meridian of North Dakota, containing a 1.0000000000 share, as more particularly described in Appendix A. 1; and
  - 5. Tribal Tract T751A of Section 19 & 30, Township 150 North, Range 93 West, Dunn County, 5th Principal Meridian of North Dakota, containing a 1.000000000 share, as more particularly described in Appendix A. 1; and
  - 6. Tribal Tract T5201 of Section 19, Township 150 North, Range 93 West, Dunn County, 5th Principal Meridian of North Dakota, containing a 1.0000000000 share, as more particularly described in Appendix A. 1; and
  - 7. Tribal Tract T15173 of Section 19, Township 150 North, Range 93 West, Dunn County, 5th Principal Meridian of North Dakota, containing a 1.0000000000 share, as more particularly described in Appendix A. 1; and



- **BE IT FURTHER RESOLVED,** that the term of the ROW(s) shall be perpetual (subject to termination in accordance with applicable federal regulations), and the requirements for compensation and bond are hereby waived; and
- **BE IT FINALLY RESOLVED**, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.

## **CERTIFICATION**
