

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled, "Authorizing the Tribal Chairman to Execute an Offer and Lease to BIA for Space in the Tribal Administration Building"

- WHEREAS, The Mandan Hidatsa and Arikara Nation (the "Nation"), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and Bylaws (the "Constitution") under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article IX, Sections 1 and 3 of the Constitution, provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS, Article VI, Section 5(c) of the Constitution specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Nation and to make expenditures from available Tribal funds for public purposes for the Nation; and
- WHEREAS, The BIA expressed an interest in leasing space within the new tribal headquarters building at 307 5th Ave. New Town ND; and
- WHEREAS, The Tribe is preparing an offer outlining the terms for such a lease; and
- WHEREAS, The federal government requires authorization for the Chairman to sign the offer and to negotiate the terms.
- **NOW THEREFORE BE IT RESOLVED,** That the Tribal Business Council authorizes the Chairman, subject to legal review, to execute the lease offer consistent with the attached Request for Lease Proposal from the General Services Administration and to negotiate and execute a final lease.
- **BE IT FINALLY RESOLVED**, The Tribal Chairman is hereby authorized to take such further action as are deemed necessary to carry out the terms and intent of this Resolution.
