WHEREAS, An application for the enrollment of Deborah Remee Gullickson, U-2874, who was born on, March 18, 1955, to Arlene (White Arm) Gullickson, Life Arikara, FB No. U-705, and Benjamin L. Gullickson, Sr., FB No. None, Life Sioux, who were residents of Inglewood, California, at the time of the birth of said child, and

WHEFEAS, the Tribal Business Council has examined the qualifications for enrollment of this child and finds that,

established a long, asctern Segment of the Fort Berihold Reservation, and that this child is entitled to enrollment under the provisions of, article II.
