RESOLUTION OF THE CREDIT COMMITTED OF THE THREE AFFILIATED TRIBUS OF THE POST BENETHOLD RESERVATION

WHEREAS, the Three Affiliated Tribes is a Federal Chartered Corporation under the Act of June 18, 193h, acting through its Tribal Eusiness Council, has authority to manage all scenesde affairs and esterprises of the Three Affiliated Tribes;

WEEFEAS, under Section 7 of the Policies and Plans for Hanaging Credit Activities of loan agreement contract I-32-Ind-6777 by and between the Three Affiliated Tribes and the United States, the Credit Committee of the Tribal Pusiness Council of the Three Affiliated Tribes was delegated authority to perform duties necessary for the promotion of a successful credit program;

Middles, under date of March 23, 1959, by Credit Committee action and Credit Committee Resolution 59-2h, all lands owned by Hars and Morcy Walker, and the income therefrom, were released as security for Loan CF-h83E, excepting therefrom certain lands contained in Sec. h, Twp. 116, P. 93 which were not specifically described in Credit Committee Lesolution 59-2h:

WHIREAS, these certain lands and the income therefrom which are retained as security for Loan CV-4838, of secessity, must be completely and specifically described, and,

WHENEAS, in order to correctly describe the lands and the income therefrom, which have been retained as security for Loan CF-L83E, it will be necessary to amend Credit Committee Resolution 59-24,

THEREFORE AE IT FESSELVED, that the wording of the "Mesolved" section of Credit Committee Resolution 57-24, dated March 23, 1959, is hereby amended to read as follows: "BE IT LESSELVED, by the Credit Committee of the Tribal Eusiness Council of the Three Affiliated Tribas that all lands, of Hans and Percy Walker, and the income therefrom are hereby released as security for Loan CF-L83E, excepting therefrom certain lands owned by Wans Walker described as Lots 1 and 2, SL/2NEI/h and SKL/h of Sec. h, Twp. 188, N. 93, containing 298.70 acres, more or less, which is retained under an Assignment of Income as security for Tillie Walker's educational Loan CF-L83E".
