RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under this Act, and

WHEREAS, The Tribal Eusiness Council of the Three Affiliated Tribes of the Fort Berthold Reservation adopted Resolution No. 59-43 on July 30, 1959, requesting that certain unsold and unrestored lots within the townsite of Parshall. North Dakota be restored to tribal ownership pursuant to the provisions of Sections 3 and 7 of the Act of June 18, 1934 (48 Stat. 984), and also requesting that certain other unsold lots within the townsite of Parshall, North Dakota, be offered for sale at the highest price obtainable, and,

WHEREAS, The Tribal Business Council has found that several Indian homes are situated on certain lots which it had requested by sold as set forth in Resolution No. 59-43, and,

WHEREAS, It is deemed advisable to amend the request contained in Resolution No. 59-43.

NOW THEREFORE BE IT RESOLVED that the 'iribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation hereby resolution No. 59-43, and substitutes this resolution in lieu thereof.

BE IT FURTHER RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, after due consideration of the needs of the city of Parshall, and the present and future needs of the people of the Three Affiliated Tribes, does respectfully request the Secretary of the Interior to restore to tribal concrship all of the unsold lots in the townsite of Parshall, North Dakota, in the area lying east of Main Street, the said unsold lots being situated in blocks 1, 12, 13, 14, 15, 16, 17, 26, 27, 28, 29, 30, 40, 41, and 42, and that all unsold lots situated west of main street be sold by the Secretary of the Interior in accordance with existing laws and regulations; that such sale be conducted in a manner to obtain the highest price obtainable at the time of the sale; that no lots be sold at less than the fair market value thereof, as determined by competent appraisers,

BE IT FURTHER RESOLVED, that the unsold lots in blocks 27 and 28 be held for use as industrial sites to be managed by the Three Affiliated Tribes as such, after they have been restored to the ownership of the Three Affiliated Tribes,

BE IT FURTHER RESCLVED, inasmuch as some of the unsold lots in the townsite of Parshall, which we have agreed may be offered for sale are occupied by members of the Three Affiliated Tribes who own the improvements situated thereon,

that in the event such occupied lots are offered for sale, the improvements of the occupants shall be moved to selected lots within the townsite of Parshall without cost to the Indian occupants or the Three Affiliated Tribes.
