

RESOLUTION OF THE COUNCIL OF THE  
THE THREE AFFILIATED TRIBES OF THE  
FORT DODGE INDIAN RESERVATION

WHEREAS, this Corporation is an Indian Chartered Corporation as defined by the Indian Corporation Act of June 1<sup>st</sup>, 1934, and authority is granted under this Act, and

WHEREAS, the Three Affiliated Tribes have been under contract with the Department of Public Instruction, State of North Dakota, for the purpose of obtaining surplus commodities for use of needy Indian people who are members of the Three Affiliated Tribes, and

WHEREAS, the State of North Dakota, Department of Public Instruction has issued notice to the Three Affiliated Tribes' governing body that the issuance of surplus commodities will be terminated as of July 1, 1960, and

WHEREAS, the Bureau of Indian Affairs has proposed to enter into agreement with the State of North Dakota, Department of Public Instruction, for the purpose of continuing the surplus commodity program for the benefit of the Three Affiliated Tribes,

WHEREAS, WHEREAS it is resolved, that the tribal governing body of the Three Affiliated Tribes hereby agrees to assume the responsibility of financing, receiving, storing, distributing, recording, reporting and protecting all phases of the surplus commodity program.

BE IT FURTHER RESOLVED, that the tribal governing body agrees to the supervision of the surplus commodity program by the branch of sellers for certification of eligibility and the branch of administration for the supervision of the financial and managerial operations of the tribal program.

CERTIFICATION

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, hereby certify that the Tribal Business Council is composed of 10 members of whom 7 constituting a quorum were present at a special meeting, thereof duly called, notice, convened and held on the 30 day of June, 1960; that the foregoing resolution was duly adopted at such meeting by the affirmative vote of 7 members, 0 members opposed, 7 passed, 0 abstentions, and that the said resolution has not been rescinded or amended in any way. One man not voting.


