whereas, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under this Act. and

MHEREAS, The Tribal Land Committee has approved the exchange of lands between the Three Affiliated Tribes and Izora White Body Giese, FB-2197, under the terms and conditions as stated below, and

NOW, THEREFORE BE IT NESOLVED, that the Tribal Business Council approve the exchange of lands held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust by the United States of America for Izora White Body Giese, FB-2197, under the terms and conditions as stated below and hereby authorizes the Chairman of the Tribal Council, the Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and do all things necessary to exchange the lands for which title is to be transferred to the United States of America in trust for the Three Affiliated Tribes and Izora White Body Giese, FB-2197, under the terms and conditions as stated below:

Izora White Body Giese, FB-2197, to convey to the United States of America in trust for the Three Affiliated Tribes, Allot. 1011a, SEANEA Sec. 27, T151N., R94W., of the 5th P.M., North Dakota, containing 40 acres, and Allot. 2197, SWA, SWASEA Sec. 26, T151N., R94W., of the 5th P.M., North Dakota, containing 200 acres, exclusive of oil, gas and other minerals, in exchange for Tribal land described as formerly part of Allot. 2277, WASEA, SEASEA, Sec. 33, T150N., R90W., 5th P.M. North Dakota, containing 120 acres, exclusive of oil, gas and other minerals. The lands are of equal value.
