- WHEREAS, this Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under this Act, and
- WHEREAS, the Real Property Management branch of the Fort Berthold Agency is presently staffed by only 5 individuals, one of whom is paid from Tribal funds, and
- WHEREAS, the branch is responsible for the leasing, acquisition and disposal, and records management for approximately one-half million acres of land, and collect, or cause to be collected, over one million dollars per year for the landowners, and
- WHEREAS, throughout the past years the volume of business has been increasing daily and the present staff has had to assume the extra work load, without any additional staff, and
- WHEREAS, the present staff has been able to keep current all transactions and record keeping by extra effort above and beyond normal requirements, and
- WHEREAS, activity in the development of our coal reserves has been started through a successful coal advertisement, and
- which will cause additional work for the branch, and
- WHEREAS, these new developments will place additional duties on the staff, which could cause a serious backlog on transactions and record keeping if clerical help is not added, and, now
- THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation hereby requests that the Bureau of Indian Affairs take immediate steps to hire two additional land clerks for the branch of Real Property Management in order that the present good management is maintained and all records be kept up to date, thereby continuing on with the additional foreseeable duties in the same manner.
