

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION


- WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under said Act; and
- WHEREAS, The Constitution and Bylaws of the Tribal Corporation charge the Tribal Business Council with the responsibility of performing all legal acts for the welfare and benefit of the Tribe and tribal members; and
- WHEREAS, The Three Affiliated Tribes is concerned about the Health, Education and Welfare of all Indians in North Dakota and will contribute their services to the educational and socio-economic advancement of all Indians; and
- WHEREAS, It is a policy of the Three Affiliated Tribes to encourage education of all ages (pre-school through adult) and to take an active part in the education of all Indian children and adults; and
- WHEREAS, The Indian communities and individuals have asked to preserve their identity and heritage and they must provide the adjustments to advance to a better life; and
- WHEREAS, The education of our children should be from the best of both cultures so that the Indian student will not lose his identity and the non-Indian student will augment his identity; and
- WHEREAS, Indian youths need courses in Indian language, values, history, and culture that will both interest them and help them become self-assured, proud, capable and stable citizens; and
- WHEREAS, Non-Indian students and citizens of North Dakota need a much better understanding and appreciation of Indian history and culture to better understand the Indian way of life and the needs of the Indian;
- NOW THEREFORE BE IT RESOLVED, by the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation supports the development of a curriculum in Indian history, language, values, and culture and in agreement with the policies of the North Dakota State Department of Education to be used in all schools and at all grade levels, where feasible, in North Dakota.
