

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

- WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under said Act; and
- WHEREAS, The Constitution and Bylaws of the Tribal Corporation charge The Tribal Business Council with the responsibility of performing all legal acts for the welfare and benefit of the Tribe and tribal members; and
- WHEREAS, The Fort Berthold Indian Reservation is a rather isolated area and opportunities for travel are limited, and
- WHEREAS, The students from our schools would truly be representative of the typical American young people--as opposed to those whose misconduct is publicized throughout the entire world, and
- WHEREAS, Our students would profit educationally by the experience, the lectures, interviews with prominent officials of the Government of India and by instructional media used in the program, and
- WHEREAS, As young ambassadors, our youth will gain insight into some of the complex problems of neighbor nations with which they must deal in the future when they assume the responsibility of citizens and leaders of America, and
- WHEREAS, Students from our schools will also have an opportunity to share their talents, knowledge, ideas, friendship, and concern for the people of India, and
- WHEREAS, The future of our nation will be determined by our international relations, and it is imperative that our contacts with them be on a friendly, positive basis; this is an opportunity to instill in the minds of the youth of today (the leaders of tomorrow) the inimitable value of international friendship, and
- NOW THEREFORE BE IT RESOLVED: The Tribal Council of the Three Affiliated Tribes approves the proposal presented by the Education Program Administrator to conduct a tour for students of the schools of the Fort Berthold Reservation to India.

CERTIFICATION
