

RESOLUTION OF THE GOVERNING BODY  
OF THE THREE AFFILIATED TRIBES  
OF THE FORT BERTHOLD RESERVATION

WHEREAS, this corporation is an Indian chartered corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under this Act; and

WHEREAS, the Tribal Business Council of the Three Affiliated Tribes has entered into an agreement with the Economic Development Administration whereby the Economic Development Administration has agreed to assist the Tribes in constructing a recreation complex known as the Four Bears Park through grants totalling One Million Two Hundred Thirty-Two Thousand Four Hundred Eighty Dollars (\$1,232,480.00) and loans totalling Three Hundred Eight Thousand One Hundred Twentey Dollars (\$308,120.00) to the Tribes for this purpose; and

WHEREAS, it is necessary, under the regulations established by the Economic Development Administration, to execute certain documents evidencing and securing the loans of Three Hundred Eight Thousand One Hundred Twenty Dollars (\$308,120.00); and

WHEREAS, the Tribal Business Council has determined that the best interests of the Tribes and the surrounding community will be served by the completion of the Four Bears Park complex and that such completion is contingent upon the closing of the loan agreement now existing between the Three Affiliated Tribes and the Economic Development Administration;

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council, through its authorized representatives, hereby authorizes the signing of the conditional assignment of the interest of the Three Affiliated Tribes in License No. DA-25-066-CIVENG-60-16, a lease agreement between the Three Affiliated Tribes of the Fort Berthold Reservation and the Army Corps of Engineers dated November 26, 1969 for the lease of land at the site of Four Bears Park, in accordance

with the request of EDA that such a conditional assignment be made as security for the above-reference loans.

CERTIFICATION
