## RESOLUTION OF THE GOVERNING BODY OF Res. THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under said Act, and
- WHEREAS, the Constitution and Corporate Charter of the Three Affiliated Tribes charge the Tribal Business Council with the responsibility of performing all actions for the benefits of the Tribe, and its members, and
- WHEREAS, since the United Tribes of North Dakota Development Corporation of North Dakota will no longer contract Johnson O'Malley Program public schools of North Dakota with the Aberdeen Area Office, Bureau of Indian Affairs, in the future school terms, and
- WHEREAS, the Tribal Business Council of the Three Affiliated Tribes desire to provide continued adequate education for the Indian children attending public schools on the Fort Berthold Reservation, namely; Parshall, New Town and Halliday.
- NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes enter into a contract with the Aberdeen Area Office, Bureau of Indian Affairs, for the administration of the Bureau's assistance program to the above-mentioned public schools (known as Johnson O'Malley).
- BE IT FURTHER RESOLVED, that the said Contract entered into be on the same terms and conditions pursuant with the Johnson O'Malley Act as established and carried out by Aberdeen Area Office, Bureau of Indian Affairs. C E R T I F I C A T I O N
