- WHEREAS, Dakota Production, Bismarck, North Dakota, has requested immediate payment of \$2,500.00 incurred cost due them for printing, and specifications for Adult Correctional Facility, Fort Berthold Reservation, Parshall, North Dakota, and
- WHEREAS, said cost expense is not included in architect contract, and Tribes' operating funds is not sufficient to pay said \$2,500.00, and
- WHEREAS, Revenue sharing guidelines provides capital expenditures may be paid provided it is duly authorized by the governing body.
- NOW, THEREFORE BE IT RESOLVED by the Tribal Business Council of the Three Affiliated Tribes to make payment of \$2,500.00 to Dakota Production, Bismarck, North Dakota, out of Tribes Revenue Sharing funds.

Dear Mr. Eagle,

Reference is made to our January 28 telephone conversation in which we discussed the payment of the \$2,500 bill from Dakota Reproductions with grant funds. Because such an expenditure was anticipated in the approved grant budget, it is permissible for the tribe to pay this bill with grant funds.

In the approved grant budget, it was anticipated that reproduction costs would be paid for out of the contingency fund. However, because of various contract revisions with F & J Construction the contingency fund is now depleted and cannot cover this \$2,500 expense. Therefore, if the tribe elects to pay the bill now with grant funds, it should be prepared to reimburse the grant budget (escrow account) \$2,500 in tribal funds. If the grant budget is not reimbursed accordingly, the tribe will find itself \$2,500 short of funds when it comes time to make final payment to either F & J Construction or Denby Deegan at the close of the pro-
