

RESOLUTION OF THE GOVERNING BODY  
OF THE THREE AFFILIATED TRIBES  
OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934 and authority is granted under this Act, and;
- WHEREAS, The Tribal Business Council of the Three Affiliated Tribes by passing Tribal Resolution No. 75-199, established a Tribal Fish and Game & Rec. Department, and;
- WHEREAS, A Program Director and Chief Game Warden have been hired and are attempting to enact the policies and procedures set forth in the Plan of Operations, and;
- WHEREAS, Funding made available, at this point, through the Title X Program only covers the salaries for the two (2) aforementioned personnel, and;
- WHEREAS, Funding for the efficient and orderly operation of the Department are non-existent, insofar as funds necessary for the procurement of vehicles, office equipment and supplies are concerned, and;
- WHEREAS, The Department of Fish, Game and Rec. is vital to the Three Affiliated Tribes of Fort Berthold as it demonstrates its ability to professionally manage its own resources, and;
- WHEREAS, Additional operating funds are necessary for the Department to enhance its credibility, and;
- NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby formally requests the Superintendent and his staff of the Fort Berthold B.I.A. Agency to take the necessary steps and follow the procedures available to provide the Tribal Fish, Game & Rec. Department with necessary funding assistance for efficient operation.

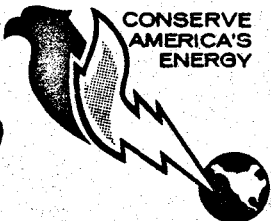
