RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under said Act; and
- WHEREAS, The Constitution and Corporation Charter of the Three Affiliated Tribes authorizes the Tribal Business Council of the Three Affiliated Tribes to engage in business enterprise; and
- WHEREAS, The Fort Berthold Reservation lost a considerable portion of the Reservation and its most productive lands to the Garrison Dam and Lake Sakakawea; and
- WHEREAS, The Tribe and its members have been unable to benefit from the existence of the said reservoir; and
- WHEREAS, An inventory of the water subject to claim by the Three Affiliated Tribes of the Fort Berthold Reservation is Just being completed and the Tribe is desireous of beginning beneficial use of the available water; and
- WHEREAS, The Bureau of Reclamation is the Governmental Agency recognized as an authority on irrigation, municipal and industrial use of water and has in the past conducted reconnaissance type investigations on the Fort Berthold Reservation; and
- WHEREAS, We understand that on agreement exists between the Bureau of Indian Affairs and the Bureau of Reclamation for the furnishing of technical and engineering services;
- NOW THEREFORE BE IT RESOLVED, That the Area Director, Aberdeen Area, is requested to contact the Regional Director of Bureau Reclamation to arrange a meeting with the Tribal Council of the Three Affiliated Tribes of the Fort Berthold Reservation to determine the assistance which could be availabe in planning and implementing the use of the Reservation water
