- NOW, THEREFORE BE IT RESOLVED that a Special meeting of the Tribal Council held on May 11th at Twin Buttes Community Hall, Ronald Little Owl was duly delegated as an alternate board member for the Three Affiliated Tribes.
- BE IT FURTHER RESOLVED that the Tribal Business Council of the Three Affiliated Tribes hereby delegates and authorizes Ronald Little Owl as an alternate board member, and will be present at the Board meeting of May 12, 1976.




