

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934 and authority is granted under said Act; and

WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorize the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and

WHEREAS, The transportation system in the North Segment Four Bears Recreation Complex Community and/or district on the Fort Berthold Indian Reservation is inadequate to meet the social and economic needs of that district and/or community; and

WHEREAS, The construction and/or improvement from State Highway 23 to and around 4 Bears Community Complex would improve the transportation system to serve the community needs;

NOW THEREFORE BE IT HEREBY RESOLVED that the Three Affiliated Tribal Business Council requests the Bureau of Indian Affairs to add the (Route 3300-2) Four Bear Recreation Complex road beginning at the State Highway 23 to and around 4 Bear Complex area and running Southerly to and around various recreation roads a distance of 2.9 miles to the Federal Indian Road System for the Fort Berthold Indian Reservation.

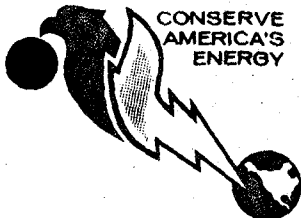
