

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION Res. No. 76-135

WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934, and authority is granted under said Act, and

WHEREAS, the Constitution and By-laws of the Three Affiliated Tribes authorizes the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe, and Tribal members, and

WHEREAS, alcoholism and its effects is the number one problem among the Indian people of the Fort Berthold Reservation, and

WHEREAS, statistical records show that the effects of alcoholism is the major cause of the alarming high rate of heart attacks, suicidal, and premature accidental tragic deaths, and

WHEREAS, there is a critical need of increased professional services.

NOW, THEREFORE BE IT RESOLVED by the Tribal Business Council of the Three Affiliated Tribes hereby strongly endorses the proposal of the North Central Mental Health and Retardation to establish a Consultation and Education Unit to provide provide and develop increase services for curtailment and prevention of existing effects of alcohol, drugs, geriatrics, and general mental health.

BE IT FURTHER RESOLVED by the Tribal Business Council wholeheartedly supports the immediate establishment of said Unit to provide the needed services.

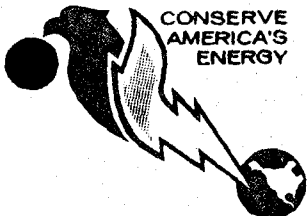
