RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934 and authority is granted under said Act; and
- WHEREAS, The Constitution and Corporate Charter of the Three Affiliated Tribes authorrizes the Tribal Business Council of the Three Affiliated Tribes to engage in business enterprizes; and
- WHEREAS, Denby M. Deegan is an enrolled member of the Three Affiliated Tribes and is licensed by the Secretary Of State to practice Architecture in North Dakota; and
- WHEREAS, The Three Affiliated Tribes Tribal Business Council is interested in the construction of an addition (additional rooms, support facilities, and public health SPA) to the Four-Bears Motor Lodge, and An Architectural Master Plan for this area; and
- WHEREAS, The Three Affiliated Tribes Tribal Business Council is interested in applying for funds through their Tribal Planning Department and to construct said project; and
- THEREFORE BE IT RESOLVED, by the Three Affiliated Tribes Tribal Business Council that Denby M. Deegan, Architect of Bismarck, North Dakota, is hereby employed by the Three Affiliated Tribes for the purpose of performing the Architectural and Engineering services for the construction of the above mentioned project or projects. Denby M. Deegan's services shall include: Schematic Design, Design Development, Construction Documents (Plans and Specifications, Mechanical, Electrical and Civil Engineering) Bid letting, Administration of the Project and Construction Inspection, Substantial Completion for Occupancy; and
- BE IT FURTHER RESOLVED, that all funds to be paid by the Three Affiliated Tribes to said
 Architectural Firm shall be conditioned or contingent upon the approval of the
 Tribal Grant Application or applications for said necessary funds which will
 be used for the above mentioned purpose. The Three Affiliated Tribes shall
 not in any event be obligated at anytime to expend any of its funds for use
 in payment of amounts payable for said purpose defined and set forth in this
 resolution. Payments to the Architect shall be made only from grant funds
 to the tribe. Upon grant application approval the Tribal Council may enter into
 a formal A/E Contract with the Architect; and
- AGAIN BE IT FURTHER RESOLVED, through mutual agreement between the Three Affiliated Tribes Tribal Business Council and Denby M. Deegan, Architect, the Tribe may elect to make partial payment to said Architect provideing tribal resources or funds are available. This partial payment shall be only for the purpose of start-up money to initiate a project into reality. This partial payment to the Architect shall be deductible from the Architects total A/E Basic Fee when the said project is funded through the Grant Application approval.
 - The Architect shall not proceed into final drawings until the project grant application is approved. The Architect may proceed only through the planning, schematic design, and design development phases.

This said partial payment to the Architect shall include:

- 1. \$35.00 Per Hour Principal's time.
- 2. 2½ X direct salaries of employees (not including secretary)
- 3. Mechanical, Electrical, Civil and special consulting fees billed to the Architect.
- 4. Travel expenses for lodging, and meals not to exceed \$40.00 per day and for transportation expences connected with the project and authorized in advance by the owner. Travel expense at \$0.15 per mile and direct air travel expenses.

Before any work commences the Fort Berthold Business Tribal Council and the Architect may agree on either of the following:

- a. Stipulated lump-some start-up fee.
- b. Direct expenses as listed above.
