

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

**RESCINDED**

WHEREAS, This nation having accepted the Indian Reorganization Act of 1934 and authority is under said Act; and **OCT 28 1986**

WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and **THREE AFFILIATED TRIBES**

WHEREAS, According to Section 5, Part K, of the Constitution and By-laws the Tribal Business Council is empowered to request the appointment or removal of employees assigned to duty on the Fort Berthold Reservation; and

WHEREAS, The Tribal Business Council have in the past, by Resolution No. \_\_\_\_\_, disapproved of the appointment of Donald Morgan as Superintendent to the Fort Berthold Reservation;

NOW, THEREFORE BE IT RESOLVED, by the Tribal Business Council that we recommend strongly the following:

- (1) Permanent transfer as Superintendent Donald Morgan from his post at the Fort Berthold Agency to take effect date of passage,
- (2) Immediate advertisement for the vacant position of Superintendent at the Fort Berthold Reservation,
- (3) Donald Morgan not be placed in any positions of authority which directly affects the Fort Berthold Reservation.

BE IT FURTHER RESOLVED, that our request be forwarded to the Area Director, Aberdeen; Commissioner of Indian Affairs; Assistant under Secretary Department of Interior, Washington, D.C.
