- WHEREAS, This nation having accepted the Indian Reorganization Act of June 18, 1934, and authority is under said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members; and
- WHEREAS, the Three Affiliated Tribes Tribal Council has reviewed the attached overall Tribal Budget for Fiscal Year 1979, and
- WHEREAS, this overall Tribal Budget includes anticipated income from all sources including earnings on investments from funds in U.S. Treasury, Grazing and farm lease fees and income, indirect costs reimbursements and other miscellaneous income, and
- WHEREAS, the Three Affiliated Tribes Tribal Council wishes to comply with fiscal double-entry type financial accounting to insure efficient and orderly governmental operations.
- NOW, THEREFORE BE IT RESOLVED, that the Three Affiliated Tribes do hereby approve of the attached overall Tribal Budget for FY '79'.
- BE IT FURTHER RESOLVED, that the Tribal Treasurer and Tribal Comptroller shall see to it that this budget is followed to its utmost and that any deviation from such shall be by further resolution only.
