

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

- WHEREAS, *This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority is under said Act; and*
- WHEREAS, *The Constitution and By-Laws and Corporate Charter of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members, and*
- WHEREAS, *The Tribal Business Council, as the governing body of the Three Affiliated Tribes, recognizes the serious unemployment and under-employment problems on the Reservation and the effects these problems have on its' enrolled members, and*
- WHEREAS, *The Tribal Business Council, as the governing body of the Three Affiliated Tribes, is concerned about the large amount of dollars leaving the Reservation economy through non-enrollees who obtain employment on the Reservation, and*
- WHEREAS, *The Tribal Business Council as the governing body of the Three Affiliated Tribes, recognizes the substantial employment opportunities that arise under its sponsorship through its many departments, and*
- WHEREAS, *The Tribal Business Council, as governing body of the Three Affiliated Tribes believes that in order to foster a stable and diversified local economy, it must guarantee employment preference to its enrolled members,*
- NOW THEREFORE BE IT HEREBY RESOLVED, *by the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, that preference and first consideration for employment opportunity, shall be extended only to enrolled members of the Three Affiliated Tribes where the enrolled member shows reasonable capacity to perform the required task.*
- BE IT FURTHER RESOLVED, *that this preference shall be extended to the membership of the Three Affiliated Tribes under any employment opportunity that falls under the sponsorship of the Three Affiliated Tribes.*

## C E R T I F I C A T I O N
