- Whereas: The Constitution and Bylaws of the Three Affiliated Tribes empowers the Tribal Business Council to revise membership rolls and to govern future membership rolls and
- Whereas, Carl William Sterud Jr., U-02953, has requested relinquishment of membership in the Three Affiliated Tribes so that he can be en-rolled with the Puyallup Tribe of Indians in Washington, and
- Whereas, we have been advised by the Enrollment Office of the Puyallup that Carl William Sterud Jr. meets the enrollment requirements for that Tribe.
- NOW: THEREFORE BE IT RESOLVED: that Carl William Sterud Jr.'s membership in the Three Affiliated Tribes is hereby relinquished effective the date of this Resolution and that his name is to be removed from the offical membership roll of the Three Affiliated Tribes: and
- BE IT FURTHER RESOLVED That the Puyallup Tribe be advised of this action by a copy of this Resolution.

In the undersigned; as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation; hereby certify that the Tribal Business Council is composed of 11 members of whom 7 constituting a quorum were present at a meeting convened and held on the 23 day of February, 1979; that theforegoing Resolution was duly adopted at such meeting by the affirmative vote of 6 members opposed; 0 members abstained; and that said Resolution has not been rescinded or amended in any way.
