WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and authority is under said Act; and

WHEREAS, the Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefits of the tribes and tribal members; and

WHEREAS, Tribal Resolution No. 79-<u>76</u> authorizes \$40,000 forty-thousand dollars to be withdrawn from the Public Facilities fund; and

NOW THEREFORE BE IT RESOLVED by the Tribal Business Council that the following shall be used in the allocation of funds per community:
