- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority is under said Act; and
- the Constitution and By-laws of the Three Affiliated Tribes WHEREAS. authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the tribes and tribal members; and
- the Alcoholism Program has a need for strengthening staff support; and WHEREAS,
- the current alcoholism budget does allow for changes within the WHEREAS, personnel line item; and
- the Alcoholism Program also has a need for the creation of a WHEREAS, maintenance line item to enable the continued operation of the half-way house; and
- the current alcoholism budget does not allow for the coverage of emergency maintenance expenses incurred by the half-way house;
- THEREFORE, BE IT RESOLVED, that the alcoholism budget reflect the continued funding of three (3) personnel with an increase in the travel line item and the creation of a line item for maintenance.
