THEREFORE, BE IT RESOLVED that the Tribal Business Council hereby approves the purchase of the land described below, exclusive of minerals, including oil and gas, from

for a cash consideration of \$ 12,000.00, which is the present fair market value, utilizing funds from the _____ account, and hereby authorizes the Chairperson of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of Indian Affairs to prepare all documents and do all things necessary to transfer title of the lands to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Reservation, to wit:
