- WHEREAS, the 95th Congress has passed legislation (S.1215 and HR 9158) "to provide for grants to our tribally controlled Community Colleges" for the purpose of providing our Indian people with access to higher educational opportunities near their families, their tribes, and their place of employment; and
- WHEREAS, On October 16, 1978, President Carter signed S. 1215, the "Tribally Controlled Community College Assistance Act of 1978"; and
- WHEREAS, S. 1215 or P.L. 95-471- the "Tribally Controlled Community College Assistance Act of 1978" authorizes to be Appropriated \$25 million for fiscal years 1980 and 1981 respectfully and \$30 million for Fiscal Year 1982; and
- WHEREAS, The Dept of the Interior/BIA has not made any efforts to request appropriations in their FY 80 budget request for implementation of P.L. 95-471; and


