RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Corporation is an Indian Chartered Corporation as defined by the Indian Reorganization Act of June 18, 1934 and authority is granted under said Act, and
- WHEREAS, The Constitution and By-Laws of the Tribal Corporation charge the Tribal Business Council with the responsibility of performing all legal acts for the welfare and benefit of the Tribal membership, and
- WHEREAS, The Tribal Business Council of the Three Affiliated Tribes is responsible for the protection of its members and their property, and
- WHEREAS, There has been an increase in the mis-use of private and public telephones within the boundaries of the Fort Berthold Reservation, and
- NOW THEREFORE BE IT RESOLVED THAT, The mis-use of telephones within the boundaries of the Fort Berthold Reservation, by:
 - Charging such service to an existing telephone number or credit card number without the authority of the subscriber thereto or the legitimate holder thereof; or
 - Charging such service to a non-existent, false, fictitious or counterfeit, telephone number, credit card number or to a suspended, terminated, expired, cancel-led, or revoked telephone number or credit card; or
 - Use a code, prearranged scheme, or other similar stategem or device whereby said person in effect, sends or receives information; or
 - Installing, rearranging or tempering with any facilities or equipment, whether physically, inductively, acoustically, or electronically; or
 - Any other trick, strategem, impersonation, false pretense, false representation, false statement, contrivance, device, or means shall be guilty of a misdemeanor, and shall be punished by a fine of not more than five hundred dollars or by imprisonment in the Managere jail for not more than six months, or by both such fine and imprisonment.
